A video has emerged on Twitter showing a fight in the ladies coach of the Delhi Metro, leading to concerns about the safety of passengers. - (iii) Limited extracurricular activities centered on moral values: Both curricular and extracurricular activities play an important role in a student's life. However, the range of extracurricular activities has been narrowed down to just sports, competitions, games, dance, and music events. Morning meetings, prayers, discussions on social problems, and other cultural activities have disappeared. Even on important days, such as the birth or death anniversary of national heroes, there are holidays instead of meaningful debates or learning opportunities on moral topics.
- 4. The influence of mass media has a significant impact on shaping the personality of young people. Television, print media, internet blogs and websites, and cinemas all play a role in this. Role models, such as movie actors and actresses, also have an influence. However, many forms of media, images, movies, and games not only normalize violence but also glorify it. The presence of violence and vulgarity in these entertainment avenues can have a negative impact on the next generation if the majority of young people consume them.
- 5. The fast pace of the economy is rewarding materialism and a focus on money. This creates an environment where socially undesirable goods and excessive fashion are marketed to vulnerable individuals. In such an unfavorable atmosphere, it is not surprising that adolescents do not prioritize high standards and personal values.
- 6. Gender bias is a significant social issue in India. It is unfortunate that even in the 21st century; parents still differentiate between their sons and daughters. In our society, sons are often preferred over daughters. Certain activities, such as going to the market alone, laughing in public places, or wearing western attire, are considered disgraceful for girls but not equally applied to boys. This unequal treatment gives boys unnecessary freedom, making them believes they are superior and can do whatever they want.

- 7. During adolescence, young people begin to analyze issues, develop viewpoints, question the status quo, and strive to develop their own personalities. The teaching method should not only focus on exams but also incorporate practical and continuous education and evaluation. Nationalism and patriotism should also be part of the value education curriculum.
- 4) Additional activities like school assemblies, extracurricular activities, celebrations of different religious festivals, work experience, team games, subject clubs, and social service programs can promote values like cooperation, honesty, integrity, discipline, and social responsibility. Children should learn and practice rituals, traditions, and religious activities while embracing modernization.
- 5) Teachers should promote high human values in a global context. They should help students relate value education to real-life situations, enabling them to distinguish between lies, fantasies, and truth. For example, a child should understand the concept of property and that stealing is wrong.
- 6) Moral values can be developed through both formal and non-formal systems. Organizations like NSS, NCC, Boys' Scouts, and Girls' Guide can greatly contribute to this development. Emphasis should be placed on cultivating moral conduct and habits suitable for modern living to ensure successful adaptation to life situations.
- 7) Apart from teachers, parents and communities should also be mindful that adolescents should not engage in antisocial activities. They should protect them from the negative effects of society that may hinder their personal growth.
- 8) It is crucial to provide economic stability, employment opportunities, an anti-depressive environment, and essential infrastructure for adolescents in society.
